### **PHOTO ID REQUIREMENTS FOR VOTERS:**

If you are voting in person during early voting or on Election Day, a Federal or State of Tennessee Government issued photo ID is required for voting, unless an exception applies. ### **ATTENTION CANDIDATES:**

Within 100 feet from the designated entrances and the building in which the polling place is located, the display of campaign posters, signs, or other campaign materials, distribution of campaign materials, and solicitation of votes for or against any person, political party, or position on a question are prohibited. No campaign posters, signs or other campaign literature may be displayed on or in any building in which a polling place is located. (T.C.A. 2-7-111) During the hours in which the polls are open, candidates are not to enter a polling place unless they are there to cast their vote. (TCA 2-7-103)
